PART B: PATENTS AND INDUSTRIAL DESIGNS

PATENTS

Patents are published in a lot of countries and in many languages. This means that finding the information in journals and on patent documents can be quite difficult. To make it easier to find specific information on a patent, an international system has been devised. This system codifies patent information by assigning a specific number to each piece of information about the history of a patent.

The <u>I</u>nternationally agreed <u>N</u>umbers for the <u>I</u>dentification of <u>D</u>ata (INID) assigns a specific number to each piece of information contained in a patent application document. These numbers are therefore used in this journal to identify information with regard to each patent application.

The INID numbers are always in parentheses and always immediately precede the information to which they refer. For example: the INID number (21) stands for the application number; while the INID number (71) stands for the name of the applicant and the INID number (22) is for the date on which the application was filed with the Intellectual Property Office of Papua New Guinea.

The applications with the PCT¹ application numbers are applications entering the national phase in Papua New Guinea²
